Guide to Hiring an Expert Process Server

You need a professional to hand-deliver important court documents to someone and you want it done with no hassles or stress and for a fair price.

Three Tips to Keep in Mind when Hiring a Process Server:

1) Don't get burned by "hidden" fees.

Be careful of companies that quote a low price for service as they inevitably find ways to **tack on extra fees** for additional attempts at service, stakeouts, mileage, waiting time, and on and on. Nail down a firm price so there are **no surprises** and ask how many attempts are made for the fee.

I charge one flat rate starting at \$75 for **unlimited attempts** at service and I never ask for one penny more, no matter how difficult it may prove to serve your case. You always know and agree to exactly what the fee will be.

2) Many companies demand payment up front.

If you pay a stranger now, what motivation do they have to get your papers served quickly and efficiently? How do you know they are out there working relentlessly for you?

Do you get a refund if they cannot get the job done? (*the answer is no...*)

I never require payment before the job is done so you know I am working to serve your papers as quickly as I can because I don't get paid until I do. You know your papers were served properly before you ever pay a penny and if I cannot get your job done for some *crazy* reason, **you pay nothing at all.**

3) Expect additional fees if your case requires special attention.

If the deadline to serve your papers is within just a few days, your defendant moved, is on a military base or you need to enact an elaborate ruse to get them served, virtually any process service company will require additional fees to accommodate your needs.

There is added expense to serves with special requirements like these and a cost to prioritize your case above other jobs. The additional fees help cover these added expenses. An expert process server's fees will be fair and money well spent to make sure your papers are served properly.
